AN ORDINANCE AMENDING SECTIONS 15.80.050 AND 15.80.060 AND ADDING A NEW SECTION 15.80.080 OF THE ANCHORAGE MUNICIPAL CODE PROVIDING FOR A FINE SCHEDULE FOR OFFENSES RELATING TO THE VEHICLE INSPECTION MAINTENANCE PROGRAM TO COMPLY WITH THE REQUIREMENTS SET FORTH IN ALASKA STATUTE 28.05.151 AND ALASKA STATUTE 29.25.070.

THE ANCHORAGE ASSEMBLY ORDAINS

Section 1: Anchorage Municipal Code subsection 15.80.050.C is hereby amended to read as follows:

15.80.050 Penalties.

A. (No change.)

B. (No change.)

C The fine for a violation of section 15.80.010.A or B shall be \$200.00 in accordance with the fine schedule set forth in AMC 15.80.080. A person receiving a citation for such violation may submit the fine amount without a court appearance.

E. (No change.)

Section 2: Anchorage Municipal Code section 15.80.060 is hereby amended to read as follows

15.80.060 Waiver for seasonal use vehicles.

A (No change.)

B An application for a seasonal use waiver may be completed at the I/M program office and must be signed by the registered owner of the vehicle. Upon approval by the program administrator of the seasonal use waiver application, the vehicle owner shall be issued an I/M certificate of inspection waiver. The division of motor vehicles will issue seasonal waivers tabs in accordance with AS 46.14 [OPERATION OF VEHICLES WITH SEASONAL USE TABS SHALL BE ILLEGAL DURING THE MONTHS OF NOVEMBER, DECEMBER, JANUARY, FEBRUARY AND MARCH.]

C Operation of vehicles with seasonal use tabs shall be illegal during the months of November, December, January, February, and March. Vehicle owners cited by state or local enforcement agencies for violation of the seasonal use waiver requirements shall

[WILL] be assessed a fine of \$300.00 in accordance with the fine schedule set forth in AMC 15.80.080 and the seasonal waiver shall [WILL] be permanently revoked.

D (No change.)

Section 3: Anchorage Municipal Code chapter 15.80 is hereby amended by adding a new section, to be numbered 15.80.080, which section reads as follows:

15.80.080 Fine schedule.

In accordance with AS 28.05.151 and AS 29.25.070, citations for the following offenses may be disposed of as provided in AS 12.25.195-.230, without a court appearance, upon payment of the fine listed below:

15.80.010.A	Failure to have current I/M inspection	\$200.00
15.80.010.B	Failure to have current I/M inspection—vehicle fleet	\$200.00
15.80.060.C	Operation of a motor vehicle with seasonal use tabs out of season	\$300.00

Section 4. This ordinance shall become effective immediately upon passage and approval by the Assembly.
