THE ANCHORAGE ASSEMBLY ORDAINS:

Section 1: Section 5(B) of Anchorage Ordinance 99-104 is amended to read as follows:

<u>Section 5:</u> The ordinance referenced in Section 1 above shall become effective upon satisfaction of the following:

B. The Director of the Department of Community Planning and Development determines that the special limitations set forth in Section 2 above have the written consent of the owners of the property within the area described in Section 1 above. The Director of the Department of Community Planning and Development shall make such a determination only if he/she receives evidence of the required consent within <u>365</u> [120] days after the date on which this ordinance is passed and approved.

Section 2: This ordinance shall become effective immediately upon passage and approval by the Anchorage Assembly.
