## THE ANCHORAGE ASSEMBLY RESOLVES

Section 1: That the sum of Eighteen Thousand Dollars Nine Hundred Dollars $(\$ 18,900)$ is hereby appropriated from the Anchorage Metropolitan Police Service Area (0151) Fund Balance to the Anchorage Police Department to assist in the litigation of Gallion v. $A P \& F R S$, Case No. 3AN-98-4563.

Section 2: That the sum of Ten Thousand Five Hundred Dollars $(\$ 10,500)$ is hereby appropriated from the Fire Service Area (0131) Fund Balance to the Anchorage Fire Department to assist in the litigation process of Gallon v. AP\&FRS, Case No. 3AN-98-4563.
