A RESOLUTION OF THE MUNICIPALITY OF ANCHORAGE ACCEPTING AND APPROPRIATING FIVE HUNDRED THOUSAND DOLLARS (\$500,000) FROM THE FEDERAL EMERGENCY MANAGEMENT AGENCY (FEMA) TO THE FEDERAL CATEGORICAL GRANTS FUND (0241) UNDER THE NEW PROJECT IMPACT PROGRAM INITIATIVE; AUTHORIZING THE CONTRIBUTION OF EIGHTY THOUSAND DOLLARS (\$80,000) FROM THE FEDERAL CATEGORICAL GRANTS FUND TO THE AREAWIDE GENERAL CIP FUND (0401) FOR ADDITIONAL RETROFITTING OF THE NEW EMERGENCY OPERATIONS CENTER; AND AUTHORIZING THE CONTRIBUTION OF SIXTEEN THOUSAND TEN DOLLARS (\$16,010) FROM THE ANCHORAGE FIRE DEPARTMENT AREAWIDE GENERAL FUND (0101) TO THE FEDERAL CATEGORICAL GRANTS FUND (0241) TO PAY INDIRECT ADMINISTRATIVE CHARGES NOT FUNDED BY FEMA UNDER THE PROJECT IMPACT PROGRAM INITIATIVE.

THE ANCHORAGE ASSEMBLY RESOLVES:

Section 1: That the sum of Five Hundred Thousand Dollars (\$500,000) is hereby accepted and appropriated from the Federal Emergency Management Agency (FEMA) to the Federal Categorical Grants Fund (0241) under the new Project Impact Program initiative.

Section 2: That a contribution of Eighty Thousand Dollars (\$80,000) is hereby authorized from the Federal Categorical Grants Fund (0241) to the Areawide General CIP Fund (0401) for additional retrofitting of the new Emergency Operations Center.

Section 3: That a contribution of Sixteen Thousand Ten Dollars (\$16,010) is hereby authorized from the Anchorage Fire Department Areawide Fund (0101) to the Federal Categorical Grants Fund (0241) to pay indirect administrative charges not funded by FEMA under the Project Impact Program Initiative.

Section 2: That this Resolution shall become effective immediately upon passage and approval by the Anchorage Municipal Assembly.
