A RESOLUTION OF THE MUNICIPALITY OF ANCHORAGE REVISING THE 1999 GENERAL GOVERNMENT OPERATING BUDGET TO PROVIDE FOR AN INCREASE OF SALARIES IN ACCORDANCE WITH THE ANCHORAGE JOINT CRAFTS COUNCIL CONTRACT AGREEMENT

WHEREAS, the Anchorage Joint Crafts Council (JCC) contract was approved on November 15, 1998; and

WHEREAS, the approved contract calls for a cost of living increase in 1999 equal to the total percentage change of the Anchorage Consumer Price Index (all urban consumers) from December 31, 1997 to December 31, 1998 with a minimum increase of one percent and a maximum increase of three and one-half percent; and

WHEREAS, the official Consumer Price Index (CPI) for the period December 31, 1997 to December 31, 1998 has been determined to be one and one-tenth percent;
