WHEREAS, the Anchorage Assembly approved AO. No. 99-46 (S) relating to the FY 1999-2000 budget for the Anchorage School District on March 23, 1999, in accordance with Article VI, Section 6.05, of the Municipal Charter; and

WHEREAS, the qualified voters of the Municipality of Anchorage approved the education-related bond proposition that was on the April 20, 1999 Municipal Election ballot, Proposition 11; and

WHEREAS, the Anchorage School District's Debt Service Fund is being increased by \$883,589 of which \$833,578 is the taxpayers' portion of the estimated six-month interest payment on the first issuance of \$35 million of the \$173.15 million authorized bonds approved by the qualified voters of the Municipality of Anchorage on April 20, 1999;
