A RESOLUTION OF THE MUNICIPALITY OF ANCHORAGE APPROPRIATING SEVEN HUNDRED FORTY-SEVEN THOUSAND DOLLARS $(5747,000)$ OF REVENUES FROM WITHIN THE AREAWIDE GENERAL CAPITAL IMPROVEMENT FUND (401), TWO HUNDRED EIGHTYFIVE THOUSAND FIVE HUNDRED DOLLARS $(\$ 285,500)$ FROM WITHIN THE ANCHORAGE PARKS AND RECREATION CAPITAL IMPROVEMENT FUND (461), AND THIRTY-EIGHT THOUSAND DOLLARS ( $\$ 38,000$ ) FROM WITHIN THE CHUGIAK-EAGLE RIVER PARKS AND RECREATION SERVICE AREA CAPITAL IMPROVEMENT FUND (462) FOR FACLITY ImPROVEMENTS AT THE ALASKA CENTER FOR THE PERFORMING ARTS, WILLIAM A. EGAN CIVIC AND CONVENTION CENTER, GEORGE M. SULLIVAN ARENA, ANCHORAGE GOLF COURSE, BEN BOEKE/DEMPSEY ANDERSON ICE ARENAS, AND THE HARRY J. MCDONALD MEMORIAL CENTER.

THE ANCHORAGE ASSEMBLY RESOLVES.
Section 1. That Seven Hundred Forty-seven Dollars $(\$ 747,000)$ from within the Areawide General Capital Improvement Fund is appropriated for 1999 improvements to the Alaska Center for the Performing Arts, Egan Civic and Convention Center, Sullivan Arena, and the Anchorage Golf Course.

Section 2. That Two Hundred Eighty-five Thousand Five Hundred Dollars $(\$ 285,500)$ from within the Anchorage Parks \& Recreation Capital Improvement Fund is appropriated for 1999 improvements to the Ben Boeke and Dempsey Anderson Ice Arenas.

Section 3. That Thirty-eight Thousand Dollars $(\$ 38,000)$ from within the Chugiak-Eagle River Parks \& Recreation Service Area Capital Improvement Fund is appropriated for 1999 improvements to the Harry J. McDonald Memorial Center.

Section 4. This Resolution shall become effective immediately upon passage and approval by the Anchorage Assembly.
