A RESOLUTION OF THE ANCHORAGE MUNICIPAL ASSEMBLY RESCINDING THE PREVIOUS  
PROTEST OF THE RENEWAL OF THE BEVERAGE DISPENSARY LIQUOR LICENSE FOR THE  
515 CLUB PURSUANT TO AR 98-19, AND CONTINUING THE PREVIOUS CONDITIONS ON THIS  
LICENSE PURSUANT TO AR 95-374 AS AMENDED

WHEREAS, the Anchorage Municipal Assembly previously protested the renewal of the beverage  
dispensary liquor license associated with the 515 Club pursuant to AR 98-19; and

WHEREAS, for the past six (6) quarters (last quarter of 1997, four quarters in 1998 and the first  
quarter of 1999), the business of the 515 Club has continued to operate while the owners have appealed  
the decision of the Alcoholic Beverage Control Board upholding the protest by the Anchorage Municipal  
Assembly; and

WHEREAS, the licensed business, over the past six (6) quarters, has been operated in  
compliance with the conditions imposed on the license in that there have been no Notices of Violation  
issued by the Alcoholic Beverage Control Board and no criminal citations issued by either the Anchorage  
Police Department or any other law enforcement agency; and

WHEREAS, the owners of the licensed business have demonstrated their willingness and their  
ability to address the concerns of the Anchorage Municipal Assembly as stated in the previous protest as  
demonstrated by the Quarterly Bar Reports over the past six quarters; and

WHEREAS, it is not the policy of the Anchorage Municipal Assembly to protest liquor licenses  
which are operated in compliance with the law and the conditions imposed by the Assembly.

NOW, THEREFORE, the Anchorage Municipal Assembly resolves:

**Section 1:** That the previous protest as set forth in AR 98-19 is hereby rescinded. The protest  
shall be of no further force and effect.

**Section 2:** That the conditions previously imposed on this license pursuant to the AR 95-374  
Amended shall continue in full force and effect. A violation of those conditions can result in a subsequent  
protest by the Anchorage Municipal Assembly.

**Section 3:** That a copy of this resolution shall be provided to the Alcoholic Beverage Control  
Board.
