**THE ANCHORAGE ASSEMBLY RESOLVES**


**Section 1:** That the sum of Twenty-Five Thousand Dollars (\$25,000) is hereby appropriated from the Areawide General (0101) Fund Balance to the Department of Finance to amend the sole source contract with Preston, Gates & Ellis to obtain a reappraisal of the Captain Cook Hotel and assist in the litigation of property tax assessment appeals filed by the Hickel Investment Company.

**Section 2:** That this Resolution shall become effective immediately upon passage and approval by the Anchorage Municipal Assembly.


