11 A RESOLUTION OF THE ANCHORAGE MUNICIPAL ASSEMBLY SUPPORTING STATE
12 LEGISLATION WHICH PROVIDES A MANNER AND METHOD OF ALASKA PUBLIC
13 UTILITIES COMMISSION DEREGULATION WHICH PROVIDES THE ANCHORAGE
14 RATEPAYERS PROTECTION FROM INCREASED COST OF SERVICES TOGETHER WITH
15 SAFE AND RELIABLE SERVICE AND TAXPAYERS PROTECTION FROM A LOSS OF
16 VALUE OF THE TAXPAYERS' INVESTMENT

20 WHEREAS, the Municipality of Anchorage provides refuse collection pursuant to
21 ordinance as provided for in AS 29.35.050;
22

23 WHEREAS, the State Legislature has for many years discussed deregulation of refuse
24 collection;
25

26 WHEREAS, the Municipality of Anchorage supports deregulation of refuse collection
27 services provided that the Anchorage ratepayers are protected from increased costs of service and
28 are provided safe and reliable services and the Anchorage taxpayers are protected from a loss of
29 value of the taxpayers' investment in refuse collection services;
30

31 NOW, THEREFORE, the Anchorage Assembly resolves:
32

33 Section 1: That the Anchorage Assembly hereby supports legislation which would provide
34 a method and manner of Alaska Public Utilities Commission deregulation of refuse collection
35 services which provides the Anchorage ratepayers safe, reliable services at a reasonable cost and
36 the Anchorage taxpayers no loss of value in their investment. Such legislation should not alter the
37 provisions of AS 29.35.050(a), should provide an option to the Municipality of Anchorage to
38 maintain its own refuse collection, and should allow the Anchorage Assembly to exercise
39 regulatory powers similar to those contained in AS 42.05.

41 Section 2: That the Municipal Clerk shall forward copies of this resolution to the Governor
42 and the Alaska State Legislature immediately upon passage and approval.
