ANCHORAGE, ALASKA 1 2 AR NO. 99- 109 3 A RESOLUTION OF THE MUNICIPALITY APPROPRIATING FIFTY ONE MILLION FORTY 4 THOUSAND DOLLARS (\$51,040,000) OF PROCEEDS OF GENERAL OBLIGATION BONDS 5 TO THE AREAWIDE CIB FUND (401), ANCHORAGE FIRE SERVICE AREA CIB FUND (431), 6 ANCHORAGE ROADS AND DRAINAGE SERVICE AREA CIB FUND (441), ANCHORAGE 7 PARKS AND RECREATION SERVICE AREA CIB FUND (461), AND THE EAGLE RIVER-8 CHUGIAK PARKS AND RECREATION SERVICE AREA CIB FUND (462) TO PAY THE COSTS 9 OF PUBLIC SAFETY, CEMETERY, FIRE PROTECTION, ROAD, STORM DRAINAGE, PARKS 10 AND RECREATION AND RELATED CAPITAL IMPROVEMENT PROJECTS; AND 11 CONTRIBUTING SEVEN HUNDRED TWELVE THOUSAND FIVE HUNDRED DOLLARS 12 (\$712,500) FROM THE ANCHORAGE ROADS AND DRAINAGE SERVICE AREA CIB FUND 13 (441), FOUR HUNDRED EIGHTY FOUR THOUSAND FIVE HUNDRED DOLLARS (\$484,500) 14 FROM THE ANCHORAGE PARKS AND RECREATION SERVICE AREA CIB FUND (461), AND 15 ONE HUNDRED THOUSAND DOLLARS (\$100,000) FROM THE EAGLE RIVER-CHUGIAK 16 PARKS AND RECREATION SERVICE AREA CIB FUND (462) TO THE EQUIPMENT 17 MAINTENANCE INTERNAL SERVICE FUND (601) FOR THE PURCHASE OF STREET 18 MAINTENANCE VEHICLES, PARKS AND RECREATION VEHICLES AND EQUIPMENT 19 20

THE ANCHORAGE ASSEMBLY RESOLVES:

22 <u>Section 1</u>. That three million six hundred five thousand dollars (\$3,605,000) of 24 proceeds of general obligation bonds of the Municipality of Anchorage be appropriated to the 25 Areawide CIB Fund (401) to pay the costs of public safety, cemetery, and related capital 26 improvement projects in the Municipality of Anchorage as approved by the voters in the general 27 election held April 20, 1999.

28 29 <u>Section 2</u>. That nine million five hundred forty thousand dollars (\$9,540,000) of 30 proceeds of general obligation bonds of the Municipality of Anchorage be appropriated to the 31 Anchorage Fire Service Area CIB Fund (431) to pay the costs of fire facility, fire suppression and 32 related capital improvement projects in the Anchorage Fire Service Area as approved by the 33 voters in the general election held April 20, 1999.

35 Section 3. That twenty nine million nine hundred sixty thousand dollars
36 (\$29,960,000) of proceeds of general obligation bonds of the Municipality of Anchorage be
37 appropriated to the Anchorage Roads and Drainage Service Area CIB Fund (441) to pay the costs
38 of road, storm drainage and related capital improvement projects in the Anchorage Roads and
39 Drainage Service Area as approved by the voters in the general election held April 20, 1999.

40Section 4.That the sum of seven hundred twelve thousand five hundred dollars41Section 4.That the sum of seven hundred twelve thousand five hundred dollars42(\$712,500) be contributed from the Anchorage Roads and Drainage Service Area CIB Fund

(0441) to the Equipment Maintenance Internal Service Fund (0601) to purchase street maintenance vehicles and equipment.

<u>Section 5</u>. That five million nine hundred ninety five thousand dollars (\$5,995,000) of proceeds of general obligation bonds of the Municipality of Anchorage be appropriated to the Anchorage Parks and Recreation Service Area CIB Fund (461) to pay the costs of improving parks and recreation facilities and related capital improvement projects in the Anchorage Parks and Recreation Service Area as approved by the voters in the general election held April 20, 1999.

<u>Section 6</u>. That the sum of four hundred eighty four thousand five hundred dollars (\$484,500) be contributed from the Anchorage Parks and Recreation Service Area CIB Fund (461) to the Equipment Maintenance Internal Service Fund (0601) to purchase parks and recreation vehicles and equipment.

<u>Section 7</u>. That one million nine hundred forty thousand dollars (\$1,940,000) of proceeds of general obligation bonds of the Municipality of Anchorage be appropriated to the Eagle River-Chugiak Parks and Recreation Service Area CIB Fund (462) to pay the costs of improving parks and recreation facilities and related capital improvement projects in the Eagle River-Chugiak Parks and Recreation Service Area as approved by the voters in the general election held April 20, 1999.

<u>Section 8</u>. That the sum of one hundred thousand dollars (\$100,000) be contributed from the Eagle River-Chugiak Parks and Recreation Service Area CIB Fund (462) to the Equipment Maintenance Internal Service Fund (601) to purchase parks and recreation vehicles and equipment.


