A RESOLUTION OF THE MUNICIPALITY OF ANCHORAGE ACCEPTING WHEN TENDERED TWO HUNDRED FIFTY THOUSAND DOLLARS (\$250,000) FROM THE FEDERAL AVIATION ADMINISTRATION AIRPORT IMPROVEMENT PROGRAM GRANT, AND EIGHT THOUSAND THREE HUNDRED THIRTY FOUR DOLLARS (\$8,334) FROM THE ALASKA STATE DEPARTMENT OF TRANSPORTATION AND PUBLIC FACILITIES GRANT; AND APPROPRIATING SAID GRANTS AND EIGHT THOUSAND THREE HUNDRED THIRTY THREE DOLLARS (\$8,333) FROM AIRPORT RETAINED EARNINGS TO MERRILL FIELD'S CAPITAL IMPROVEMENT FUND FOR ACQUISITION OF SNOW REMOVAL EQUIPMENT.

WHEREAS, in anticipation of the Federal Aviation Administration offering the Municipality of Anchorage a grant of funds in the amount of Two Hundred Fifty Thousand Dollars (\$250,000); and

WHEREAS, in anticipation of the State of Alaska offering the Municipality of Anchorage a grant of funds in the amount of Eight Thousand Three Hundred Thirty Four Dollars (\$8,334); and

WHEREAS, the grant amounts will be adjusted by the granting agencies to actual expenditures at time of closing; and

WHEREAS, Merrill Field's snow removal equipment requirements are very demanding due to the quantity of snow received and the volume of air traffic served which requires prompt removal of snow accumulations.

NOW, THEREFORE, BE IT RESOLVED, by the Assembly of the Municipality of Anchorage:

Section 1. That the Municipality of Anchorage hereby accepts, when tendered, the Federal Aviation Administration (FAA) Grant offer of Two Hundred Fifty Thousand Dollars (\$250,000) and hereby undertakes and agrees to use those funds for the acquisition of Snow Removal Equipment.

Section 2. That the Municipality of Anchorage hereby accepts, when tendered, the State of Alaska Department of Transportation and Public Facilities (SOA DOT&PF) grant for Eight Thousand Three Hundred Thirty Four Dollars (\$8,334), and appropriates both grants and \$8,333 from airport retained earnings to Merrill Field's Capital Improvement Fund.

Section 3. The Mayor, or Municipal Manager, is authorized to execute an agreement with the FAA and with the SOA DOT&PF and provide information as may be required of the Municipality of Anchorage.

Section 4. This Resolution shall take effect immediately upon passage and approval.
