A RESOLUTION OF THE MUNICIPALITY OF ANCHORAGE APPROPRIATING ONE MILLION FOUR HUNDRED TWENTY THREE THOUSAND NINE HUNDRED DOLLARS (\$1,423,900) OF 1999 TAX REVENUES FROM THE CBERRRSA FUND (0119) TO THE CHUGIAK, BIRCHWOOD, EAGLE RIVER RURAL ROAD SERVICE AREA (CBERRRSA) CAPITAL IMPROVEMENT PROGRAM MILL LEVY FUND (0419) FOR ROAD AND DRAINAGE CAPITAL IMPROVEMENT PROJECTS

WHEREAS, the Department of Public Works is authorized one Mill from the CBERRRSA Mill Levy for Road and Drainage Capital Improvement Projects in the CBERRRSA, and
