A RESOLUTION OF THE MUNICIPALITY OF ANCHORAGE ACCEPTING AND
APPROPRIATING STATE OF ALASKA LEGISLATIVE GRANTS PER SENATE BILL 32

WHEREAS, the State of Alaska has appropriated Four Million Two Hundred Ninety
Thousand Dollars (\$4,290,000) to the Municipality of Anchorage as 70% matching capital grants
to be combined with the 30% local match required per AS 37.06 for municipal capital projects; and

WHEREAS, the Administration and the Assembly have reviewed the grants offered
by the State of Alaska; and

WHEREAS, on June 15, 1999 a duly advertised public hearing was held in
accordance with Section 6.10.085 of the Municipal Code; and

NOW, THEREFORE, the Anchorage Assembly hereby resolves:

Section 1. That State grants in the amount of Four Million Two Hundred Ninety
Thousand Dollars (\$4,290,000) are hereby accepted and appropriated.

Section 2: That the amounts set forth in Section 3 for the respective departments'
funds shall be and hereby are supplemental appropriations for the 1999 fiscal year.

Section 3: That the appropriations by fund are as follows:


Section 4: That the appropriations by department are as follows:

1 Section 5: That the Municipality of Anchorage agrees to provide the 30% local
2 share of project funding for Municipal Capital Project Matching Grants as required under AS
3 37.06.

5 Section 6: That this resolution shall take effect upon approval by the Assembly or
6 final action by the Governor, whichever is later. Provided, however, that any appropriations
7 referenced in this resolution which are deleted in whole by a veto of the Governor shall not
8 become effective and any appropriations referenced in this resolution which are reduced by a veto
9 of the Governor shall become effective only to the extent that funds for those appropriations
10 remain after exercise of the veto.
