A RESOLUTION OF THE MUNICIPALITY OF ANCHORAGE ACCEPTING AND APPROPRIATING STATE OF ALASKA LEGISLATIVE GRANTS PER SENATE BILL 32

WHEREAS, the State of Alaska has appropriated Four Million Two Hundred Ninety Thousand Dollars (\$4,290,000) to the Municipality of Anchorage as 70% matching capital grants to be combined with the 30% local match required per AS 37.06 for municipal capital projects; and

WHEREAS, the Administration and the Assembly have reviewed the grants offered by the State of Alaska; and

WHEREAS, on <u>June 15, 1999</u> a duly advertised public hearing was held in accordance with Section 6.10.085 of the Municipal Code; and

NOW, THEREFORE, the Anchorage Assembly hereby resolves:

Section 1. That State grants in the amount of Four Million Two Hundred Ninety Thousand Dollars (\$4,290,000) are hereby accepted and appropriated.

Section 2: That the amounts set forth in Section 3 for the respective departments' funds shall be and hereby are supplemental appropriations for the 1999 fiscal year.
