1 A RESOLUTION OF THE MUNICIPALITY OF ANCHORAGE APPROPRIATING ONE MILLION 2 DOLLARS (\$1,000,000) FROM THE ANCHORAGE METROPOLITAN POLICE SERVICE AREA 3 OPERATING FUND (151) TO THE ANCHORAGE METROPOLITAN POLICE SERVICE AREA 4 CAPITAL IMPROVEMENT PROGRAM FUND (451) FOR COSTS ASSOCIATED WITH 5 IMPLEMENTATION OF MOBILE DATA TECHNOLOGY IN THE ANCHORAGE POLICE 6 DEPARTMENT 7

WHEREAS, on November 24, 1998 the Anchorage Assembly adopted the Approved 1999 General Government Operating Budget (AO 98-166 as amended); and

WHEREAS, Section 6 of AO 98-166, as amended, included an appropriation of
 \$1,000,000 from Anchorage Metropolitan Police Service Area Capital Improvement Fund (451) to
 Anchorage Metropolitan Police Service Area Operating Fund (151); and

15 WHEREAS, it is unlikely that the additional \$1,000,000 appropriation to the 16 Anchorage Metropolitan Police Service Area Operating Fund will be needed for 1999 operating 17 expenses; and

WHEREAS, the Municipality of Anchorage has received approval for a \$2.4 million
 grant from the U.S. Department of Justice which will provide partial funding for the Municipality's
 implementation of Mobile Data Technology; and

WHEREAS, this appropriation will reinstate capital budget funding originally
 identified for Mobile Data Technology, in compliance with U.S. Department of Justice grant terms
 prohibiting the supplanting of local funds programmed for grant projects.

NOW, THEREFORE, THE ANCHORAGE MUNICIPAL ASSEMBLY HEREBY RESOLVES

29 <u>Section 1.</u> That the sum of One Million Dollars (\$1,000,000) is hereby 30 appropriated from the Anchorage Metropolitan Police Service Area Operating Fund (151) to the 31 Anchorage Metropolitan Police Service Area Capital Improvement Program Fund (451) for costs 32 associated with the implementation of mobile data technology in the Anchorage Police 33 Department.
