A RESOLUTION APPROPRIATING THE ANNUAL FFY99 ENTITLEMENT GRANTS FROM THE U.S. DEPARTMENT OF HOUSING AND URBAN DEVELOPMENT IN THE AMOUNT OF TWO MILLION TWO HUNDRED SIXTY-EIGHT THOUSAND DOLLARS (\$2,268,000) FOR THE COMMUNITY DEVELOPMENT BLOCK GRANT (CDBG), NINE HUNDRED SIXTY-FIVE THOUSAND DOLLARS (\$965,000) FOR HOME INVESTMENT PARTNERSHIPS (HOME) PROGRAM, AND EIGHTY THOUSAND DOLLARS (\$80,000) FOR EMERGENCY SHELTER GRANTS (ESG), TO THE FEDERAL CATEGORICAL GRANTS FUND (241).

WHEREAS, the Municipality of Anchorage has submitted its *1999 Action Plan* of the *1995-2000 Consolidated Housing and Community Development Plan* to the U. S. Department of Housing and Urban Development, outlining the program of activities to be undertaken with Community Development Block Grant (CDBG), Home Investment Partnership (HOME) and Emergency Shelter Grant (ESG) funds; and

WHEREAS, throughout the development of the *1999 Action Plan*, the Municipality of Anchorage actively sought participation of the public, and

WHEREAS, public testimony on the *1999 Action Plan* was invited in person at the Housing and Neighborhood Development Commission on Wednesday, March 10, 1999 and in writing for a period of 30 days; and

WHEREAS, the *1999 Action Plan* has been endorsed by resolution of the Housing and Neighborhood Development Commission.

WHEREAS, the Anchorage Municipal Assembly adopted the *1999 Action Plan* on May 11, 1999.

NOW, THEREFORE, the Anchorage Assembly Resolves

Section 1. That the subject grants from the United States Department of Housing and Urban Development for the FFY99 allocation of Community

1 Development Block Grant funds, in the amount of two million two hundred sixty-
2 eight thousand dollars (\$2,268,000), the FFY99 allocation of HOME Investment
3 Partnerships funds, in the amount of nine hundred sixty-five thousand dollars
4 (\$965,000) and FFY99 allocation of Emergency Shelter Grant funds, in amount
5 of eighty thousand dollars (\$80,000), are hereby appropriated, subject to final
6 HUD approval, to the Federal Categorical Grant Fund (241) for use in activities
7 under the ESG, CDBG and HOME programs.

9 Section 2. That the allocation of said grant funds will be based on the
10 activities outlined in the attached Assembly Memorandum, and in the 1999
11 *Action Plan* of the 1995-2000 *Consolidated Plan*, which incorporates
12 Anchorage's Continuum of Care. Accounting information is outlined in the
13 attached Assembly Memorandum, Attachment A.

15 Section 3. This resolution shall take effect immediately upon passage and
16 approval by the Anchorage Assembly.
