**A RESOLUTION OF THE ANCHORAGE MUNICIPAL ASSEMBLY HONORING
ANCHORAGE PUBLIC TRANSPORTATION ON THE 25TH ANNIVERSARY OF SERVICE
TO THE CITIZENS OF ANCHORAGE**

WHEREAS, Anchorage Public Transportation began service to residents and visitors to Anchorage, Alaska in July 1974 with two bus routes; and

WHEREAS, public transportation in Anchorage has grown to twenty bus routes, curb-to-curb service for disabled and senior citizens, and carpool/vanpool matching services; and

WHEREAS, Anchorage Public Transportation has provided almost 68 million passenger trips on People Mover buses during the past twenty-five years; and

WHEREAS, Anchorage Public Transportation has provided approximately 10 million additional passenger trips through the AnchorRIDES and Anchorage Share-A-Ride programs; and

WHEREAS, the services provided have helped reduce air pollution, traffic congestion and parking problems, and have helped provide mobility for residents and citizens; and

WHEREAS, public transportation plays a vital role in the economic and environmental quality of life for Anchorage.

NOW, THEREFORE, the Anchorage Municipal Assembly resolves that:
