## A RESOLUTION OF THE ANCHORAGE MUNICIPAL ASSEMBLY SUPPORTING "U.S. CENSUS 2000"

WHEREAS, the Census is vital to every community in Alaska in that it determines the apportionment of seats in the United States House of Representatives and the Alaska Legislature, and is the basis for the allocation of billions of dollars of Federal, State, and local funding for social and other programs; and

WHEREAS, the Census is also used to help determine where to locate roads, schools, day care centers, senior citizen centers, hospitals, and other facilities and is used to make decisions concerning business growth and jobs; and

WHEREAS, Census information is confidential, and Federal law prohibits any public
or private agency from gaining access to confidential Census data; and

WHEREAS, the State of Alaska and most municipal governments in the State recognize the importance of the Census and are committed to a full and accurate Census count, placing special emphasis on enumerating members of populations that are traditionally undercounted.

NOW, THEREFORE, the Anchorage Municipal Assembly resolves:

That the Assembly supports "U.S. Census 2000" and urges every community leader and resident to reach out to their neighbors to let them know that Census 2000 is important and to encourage them to accurately and promptly complete and return their census forms.
