A RESOLUTION OF THE ANCHORAGE MUNICIPAL ASSEMBLY RECOGNIZING AND
THANKING MARK NEWELL FOR HIS "NETDAY" EFFORTS AND ACCOMPLISHMENTS

WHEREAS, NetDay is an international effort to provide schools and facilities necessary Internet-ready wiring by the year 2000; and

WHEREAS, Alaska's NetDay coordinator, Mark Newell, has worked over the past 2 ½ years to wire and re-wire schools and facilities in Anchorage and across the state; and

WHEREAS, under Mark Newell's coordination and with the assistance of his wife, Lizzie, support group manager, Jeffrey Fritts, and numerous volunteers, businesses and organizations, NetDay has reached 46 school districts, 467 schools and 7,927 classrooms since the program's introduction to Alaska; and

WHEREAS, according to the Alaska Science and Technology Foundation, Mark Newell is credited with "single-handedly making Alaska's schools some of the most technologically advanced in the country in terms of Internet access." ; and

WHEREAS, the NetDay project will soon end as the last school in the district to be wired - Chugiak High School - is completed in August.

NOW, THEREFORE, the Anchorage Assembly resolves:

That the Assembly recognizes and thanks

Mark Newell

for his "NetDay" efforts and accomplishments, and further thanks the many volunteers, businesses and organizations who assisted Mark in this worthy project.
