1 A RESOLUTION OF THE MUNICIPALITY OF ANCHORAGE, ALASKA,
2 ACCEPTING AND APPROPRIATING STATE OF ALASKA MATCHING GRANT
3 FUNDS IN THE AMOUNT OF ONE MILLION FIVE HUNDRED THOUSAND
4 DOLLARS (\$1,500,000) FOR PROJECTS CONSTRUCTED UNDER THE ADEC
5 MATCHING GRANT PROGRAM (SENATE BILL 32)

8 WHEREAS, the State of Alaska (the "State") has appropriated *One Million*
9 *Five Hundred Thousand Dollars (\$1,500,000)* to the Municipality of Anchorage (the
10 "Municipality") to be applied toward the construction costs of water quality
11 enhancement projects determined eligible by the State of Alaska Department of
12 Environmental Conservation ("ADEC"); and

14 WHEREAS, the Municipality agrees to apply for these grant funds available
15 through this appropriation on a project-by-project basis; and

17 WHEREAS, the Municipality agrees to accept the terms and conditions of this
18 appropriation and each subsequent State grant offer; and

20 WHEREAS, there is a need for these water quality enhancement projects; and

21
22 WHEREAS, the Municipality agrees to maintain said projects; and

24 WHEREAS, on 7-20, 1999, a duly advertised public hearing was held in
25 accordance with Section 6.10.085 of the Municipal Code.

27 NOW THEREFORE, the Assembly of Anchorage resolves

28
29 Section 1. That the subject State grants in the amount of *One Million Five*
30 *Hundred Thousand Dollars (\$1,500,000)* granted to the Municipality are hereby
31 accepted and appropriated.

33 Section 2. That the Mayor of Anchorage acknowledge the acceptance of this
34 appropriation and that he transmit to the State an executed copy of this resolution
35 accepting said appropriation.

Section 3. That the net appropriations by Department are as follows:

Section 4. That this resolution shall take effect upon approval by the Assembly or final action by the Governor, whichever is later, provided, however, that any portion of the appropriation referenced in this resolution which is reduced by veto of the Governor shall become effective only to the extent the funds for this appropriation remain after exercise of the veto.
