A RESOLUTION AUTHORIZING THE MUNICIPALITY OF ANCHORAGE, PUBLIC TRANSPORTATION DEPARTMENT TO FILE FOR A FEDERAL TRANSIT ADMINISTRATION SECTION 5303 METROPOLITAN PLANNING PROGRAM GRANT, ENTER INTO A TRANSFER OF RESPONSIBILITIES AGREEMENT IN THE AMOUNT OF ONE HUNDRED SEVENTY-FIVE THOUSAND SIX HUNDRED AND FIVE DOLLARS (\$175,605) WITH THE DEPARTMENT OF TRANSPORTATION AND PUBLIC FACILITIES, STATE OF ALASKA, AND TO APPROPRIATE THESE FUNDS ALONG WITH FORTY-THREE THOUSAND NINE HUNDRED AND ONE DOLLARS (\$43,901) FOR LOCAL MATCHING FUNDS FROM THE PUBLIC TRANSPORTATION DEPARTMENT'S 1999 OPERATING BUDGET AS A CONTRIBUTION TO THE STATE CATEGORICAL GRANTS FUND (231) FOR THE TRANSIT PLANNING PROGRAM

THE ANCHORAGE ASSEMBLY RESOLVES

WHEREAS, the United States Secretary of Transportation is authorized to make grants for Mass Transportation planning programs:

WHEREAS, the contract for financial assistance will impose certain obligations upon the Municipality of Anchorage, including the provision by it of a local share of project costs.

WHEREAS, it is required by the U.S. Department of Transportation in accordance with the provisions of Title VI of the Civil Rights Act of 1964, as amended, the Municipality gives assurance that it will comply with Title VI of the Civil Rights Act of 1964 and the U.S. Department of Transportation requirements thereunder:

WHEREAS, it is the goal of the Municipality of Anchorage that minority business enterprises are utilized to the fullest extent possible in connection with this project and that definite procedures shall be established and administered to ensure that minority business shall have the maximum feasible opportunity to compete for consultant and other services contracts.

THE ANCHORAGE ASSEMBLY HEREBY RESOLVES

Section 1. That the Mayor or Municipal Manager, or such other person or persons as the Mayor or Municipal Manager designates, is authorized to execute and file applications on behalf of the Municipality of Anchorage with the State of Alaska to aid in the financing of planning assistance projects pursuant to section 5303 of the Urban Mass

1 Transportation Act of 1964, as amended.

3 Section 2. That the Mayor or the Municipal Manager, or such other person or persons
4 as the Mayor or Municipal Manager designates, is authorized to execute and file with such
5 applications an assurance or other document required by the United States Department of
6 Transportation effectuating the purpose of Title VI of the Civil Rights Act of 1964.

8 Section 3. That the Mayor or the Municipal Manager, or such other person or persons
9 as the Mayor or Municipal Manager designates, is authorized to set forth and execute
10 affirmative minority business policies in connection with this application's program of
11 projects.

13 Section 4. That the Mayor or the Municipal Manager, or such other person or persons
14 as the Mayor or Municipal Manager designates, is authorized to furnish such additional
15 information as the State of Alaska may require in connection with this application's program
16 of projects.

17
18 Section 5. That the Mayor or the Municipal Manager, or such other person or persons
19 as the Mayor or Municipal Manager designates, is authorized to enter into a Transfer of
20 Responsibilities Agreement (TORA) between the State of Alaska, Department of
21 Transportation and Public Facilities for the financing of the transit Planning Program.

22
23 Section 6. That the sum of one hundred seventy-five thousand six hundred and five
24 dollars (\$175,605) is appropriated as a grant from the Alaska Department of Public
25 Transportation and Public Facilities, when awarded, to the State Categorical Grants Fund
26 (231) for the financing of the Transit Planning Program.

27
28 Section 7. That the sum of forty-three thousand nine hundred and one dollars
29 (\$43,901) is appropriated from the Public Transportation 1999 Operating Budget as a
30 contribution to the State Categorical Grants Fund (231) to serve as the required local match.

32 Section 8. This resolution shall take effect immediately upon passage and approval.
