A RESOLUTION OF THE MUNICIPAL ASSEMBLY IMPLEMENTING A CORPORATE TRAVEL CREDIT CARD PROGRAM FOR ASSEMBLY TRAVEL AND EVALUATING A PROCUREMENT CREDIT CARD PROGRAM FOR MUNICIPAL PURCHASES

WHEREAS, the Municipality of Anchorage needs to continually evaluate ways to save taxpayer money wherever possible and no matter how minimal; and

WHEREAS, one cost saving area which has been discussed for many years is Municipal travel, specifically the implementation of a corporate travel credit card program to earn mileage awards from airline ticket purchases, hotel expenses, rental car expenses, etc; and

WHEREAS, the Assembly approved AR 94-5 on January 18,1994, which directed the Municipal Administration to:

To evaluate a corporate travel credit card program which meets the Municipality's travel needs;

To further examine cost savings using package rates and other travel discounts: and

To provide the Assembly with a corporate travel credit card program by February 15, 1994.

WHEREAS, to the best of our knowledge, the provisions of AR 94-5 were never followed through and implemented; and

WHEREAS, as the policymaking body of the Municipality, the Assembly should take the lead in implementing a corporate travel credit card program for Assembly travel; and

WHEREAS, other cost saving measures such as a procurement credit card program for Municipal purchases - as currently used by many cities across the nation including Portland, Eugene, Tacoma, and Seattle - should also be evaluated.
