A RESOLUTION OF THE MUNICIPALITY OF ANCHORAGE APPROPRIATING TWENTY-FIVE THOUSAND DOLLARS (\$25,000) FROM THE AREAWIDE GENERAL (101) FUND BALANCE TO THE DEPARTMENT OF HEALTH AND HUMAN SERVICES FOR AMENDMENT NO. 1 TO THE CONTRACT WITH GILMORE & DOHERTY FOR PROFESSIONAL LEGAL SERVICES REGARDING *ALLVEST, INC. V. MOA AND DOYON UNIVERSAL SERVICES*.

THE ANCHORAGE ASSEMBLY RESOLVES:

Section 1: That the sum of Twenty-Five Thousand Dollars (\$25,000) is hereby appropriated from the Areawide General (101) Fund Balance to the Department of Health and Human Services for Amendment No. 1 to the contract with Gilmore & Doherty for Professional Legal Services regarding *Allvest, Inc. v. MOA and Doyon Universal Services*.

Section 2: That this Resolution shall become effective immediately upon passage and approval by the Anchorage Municipal Assembly.

Subject: Amendment No. 1 to the Professional Legal Services contract from the Law Firm of Gilmore & Doherty regarding *Allvest v. MOA and Doyon Universal Services*.

In April 1999 the Law Department requested and received approval to enter into a sole source contract with Gilmore & Doherty to represent the Municipality of Anchorage in the case of *Allvest v. MOA and Doyon Universal Services*.

Once approved, the Administration requested, and received approval, for an appropriation of \$25,000 by the Anchorage Assembly from the Areawide General Fund Balance to the Department of Health and Human Services to fund the legal services. Gilmore & Doherty's retention was necessary because of their ability to provide concentrated time and efforts immediately. The lead counsel's background and experience with Municipal government affairs and familiarity with the Municipal Code were vital qualities which aided in the selection of the firm.


Amendment No. 1 will appropriate and authorize an additional Twenty-Five Thousand Dollars (\$25,000) to fund this case. A trial has been set for the end of this year and this appropriation will provide funds for the law firm to research and prepare for trial.




