A RESOLUTION OF THE ANCHORAGE MUNICIPAL ASSEMBLY RECOGNIZING THE 20th ANNIVERSARY OF BEAN'S CAFÉ

WHEREAS, in 1979, Lynne Ballew saw hungry people on the streets of Anchorage and she decided to take action and do something about the problem - this was the start of Bean's Café named after Lynne's daughter, Leesie "Bean" Ballew; and

WHEREAS, for the past twenty years, Bean's Café has been a community based and supported center where men, women, and children are provided with hot nutritious meals, a warm and safe day shelter, and information and referral assistance to health and human service programs; and

WHEREAS, with funding from United Way and the Municipality, donations from individuals, businesses, and churches, and daily volunteer assistance, Bean's Café provides the following services every day of the year to the homeless, the hungry, the unemployed, and the very poorest of our community:

The Meal and Day Shelter Program provides meals and a safe alternative to the streets - last year over 173,000 meals were provided to almost 4,000 indigent persons, and approximately 500 men, women, and children were served at the special Christmas dinner; and

The Social Services Referral Program provides referrals and direct assistance for housing, medical, transportation, rehabilitation, education, and employment - the number of referrals has increased from 15,000 in 1991 to nearly 29,000 in 1998.

NOW, THEREFORE, the Anchorage Municipal Assembly resolves:
