A RESOLUTION OF THE ANCHORAGE MUNICIPAL ASSEMBLY SUPPORTING THE PROPOSAL TO DESIGNATE THE HISTORIC TRANSPORTATION CORRIDOR THROUGH THE KENAI MOUNTAINS AND THE REGION IMMEDIATELY NORTH OF THE TURNAGAIN ARM AS A NATIONAL HISTORIC CORRIDOR

WHEREAS, the Kenai Peninsula Historical Association is sponsoring a proposal to designate the historic transportation corridor through the Kenai Mountains and the region immediately north of the Turnagain Arm as a National Historic Corridor; and

WHEREAS, through National Historic Corridor designation, Congress recognizes regions of the nation that have a combination of natural, cultural, historic and scenic resources which are so outstanding that they have national importance; and

WHEREAS, the proposed Kenai Mountains National Historic Corridor is a rugged mountainous area that has been a major gateway for developing transportation, mining, and settlement in southcentral Alaska; and

WHEREAS, National Historic Corridor designation:

Does not impose federal land ownership or regulatory control; and

Provides funding to assist communities accomplish locally identified projects which preserve local history and resources, and which enhance and develop tourism.

NOW, THEREFORE, the Anchorage Municipal Assembly resolves:

Section 1: That the Assembly supports the proposal to establish the Kenai Mountains National Historic Corridor.

Section 2: That, upon passage and approval, a copy of this resolution be forwarded to the Kenai Peninsula Historical Association.
