A RESOLUTION OF THE ANCHORAGE MUNICIPAL ASSEMBLY REQUIRING PAST
AND PRESENT TAX ROLLS BE INCLUDED AS PART OF THE EVIDENTIARY
RECORDS OF THE BOARD OF EQUALIZATION

WHEREAS, property tax assessments are public records; and

WHEREAS, at an August 10th, 1999 Assembly worksession with the members of the
Board of Equalization, concern was raised that the Board members were not allowed access to
certain information such as comparative data and previous tax rolls before making a decision on
whether or not to defend a property assessment; and

WHEREAS, during an appeal process before the Board of Equalization, we believe all
parties should be allowed equal access to all pertinent information which will assist them in
rendering a fair decision.

NOW, THEREFORE, the Anchorage Municipal Assembly resolves:

Section 1: That past and present tax rolls and supporting documentation will be part
of the evidentiary record and made available to all parties.

Section 2: This Resolution is effective immediately upon passage and approval.
