9 A RESOLUTION OF THE ANCHORAGE MUNICIPAL ASSEMBLY URGING THE
10 ADMINISTRATION TO REINSTATE ROUTES 91 AND 92 PROVIDING SERVICE TO THE
11 STUDENTS AT SERVICE HIGH SCHOOL

14 WHEREAS, during the 1999 budget savings and 2000 budget reduction exercise,
15 the Public Transportation Department deleted bus routes 90, 91, and 92 identifying these
16 routes as the lowest year-round routes in the People Mover System; and
17

18 WHEREAS, bus routes 91 and 92 provide an integral service to the residents in
19 South Anchorage who depend on public transportation for students attending Service High
20 School and to participate in after-school activities; and
21

22 WHEREAS, deletion of this service proposes a hardship on these residents, who
23 rely on these routes which are the only routes in the entire system that provide bus service
24 in this area; and
25

26 WHEREAS, it is good public policy to ensure that all citizens are provided with
27 access to public transportation.
28

29 NOW, THEREFORE, the Anchorage Assembly resolves:
30

31 Section 1: That the Administration is urged to reinstate People Mover bus service
32 on Routes 91 and 92 effective with the August 30, 1999 route changes.
33

34 Section 2: That routes 91 and 92 be included in the Public Transportation
35 Department's Year 2000 budget.
