THE ANCHORAGE ASSEMBLY RESOLVES:

That a sum not to exceed SEVENTEEN THOUSAND 16 17 NINE HUNDRED, THIRTY DOLLARS (\$17,930) is hereby appropriated 18 19 from a grant awarded by the Alaska State Council on the Arts, 20 21 FORTY THOUSAND, TWO HUNDRED, FORTY-NINE DOLLARS (\$40,249) from 22 23 the Anchorage Museum Association, TEN THOUSAND, THREE HUNDRED 24 25 TWENTY-ONE DOLLARS (\$10,321) from the Anchorage Museum 26 27 Foundation, EIGHT THOUSAND DOLLARS (\$8,000) in anticipated 28 29 miscellaneous revenues and NINETEEN THOUSAND, TWO HUNDRED, TEN 30 31 DOLLARS (\$19,210) as a contribution from appropriated funds for 32 33 Museum operating support.
