1 A RESOLUTION APPROPRIATING \$35,000 FOR THE SETTLEMENT OF *ALLVEST, INC. V.*
2 *MUNICIPALITY OF ANCHORAGE ET.AL.* AND APPROVING THE EXTENSION OF THE
3 ANIMAL CONTROL AND COMMUNITY SERVICE PATROL SERVICE CONTRACTS.

6 WHEREAS, the Assembly Memorandum accompanying this Resolution delineates the events
7 leading up to the existing animal control services contract and the proposed terms for settlement of
8 *Allvest, Inc. v. Municipality Of Anchorage et.al.* in the Superior Court, Case No. 3AN-99-5368
9 Civil; and

11 WHEREAS, the proposed settlement will fully resolve all issues in the pending litigation and
12 provide continuity in the provision of animal control and community services patrol services for the
13 Municipality; and

15 WHEREAS, the proposed settlement would be entered into solely to avoid incurring
16 additional fees and costs of litigation and the distractions of time and effort of Municipal personnel
17 in litigating the case; and

19 WHEREAS, nothing in the proposed settlement is to be construed as an admission by any
20 of the parties of any liability in the lawsuit and any liability is specifically denied; now therefore,

22 THE ANCHORAGE ASSEMBLY RESOLVES



24 Section 1. The extension of the existing Doyon Universal Services animal control services
25 contract with the Municipality for a period of six months to September 30, 2000 is hereby approved
26 and any new procurement process for securing animal control services will begin on or about
27 August 1, 2000.

29 Section 2. The renewal of the existing Allvest, Inc. community services patrol contract with the
30 Municipality extending the contract to June 30, 2000 is hereby approved.

32 Section 3. The sum of \$35,000 is hereby appropriated from the Areawide General Fund (101)
33 fund balance to Department of Health and Human Services (2250) for the settlement of *Allvest, Inc.*
34 *v. Municipality Of Anchorage et.al.* in the Superior Court.

1 **Section 4.** This resolution shall become effective immediately upon its passage and approval by
2 the Assembly.
