WHEREAS, with the 22nd Annual Alaska Agriculture Symposium to be held in Anchorage on November 12 - 13, 1999, and National Farm-City Week from November 19 - 25, 1999, the Anchorage Assembly wishes to recognize the invaluable contributions and accomplishments of all persons who work in Alaska's agricultural sector.

NOW, THEREFORE, the Anchorage Assembly resolves:

That the Anchorage Assembly recognizes

National Farm-City Week November 19 - 25, 1999
