A RESOLUTION OF THE ANCHORAGE MUNICIPAL ASSEMBLY RECOGNIZING AND SUPPORTING THE AMERICAN CANCER SOCIETY'S GREAT AMERICAN SMOKEOUT, NOVEMBER 18, 1999

WHEREAS, the American Cancer Society's GREAT AMERICAN SMOKEOUT, scheduled for November 18, 1999, encourages tobacco smokers and smokeless tobacco chewers to quit; and

WHEREAS, increasing numbers of children are experimenting with tobacco products that can produce lifetime addiction with an increased risk of cancer; and

WHEREAS, approximately 14,000 Alaskans under the age of 18 who are alive today will become addicted to and die from tobacco-caused illnesses unless current trends are reversed; and

WHEREAS, tobacco use causes a great many illnesses and also affects a wide range of the non-smoking public, with children being specifically susceptible to illness from second-hand smoke; and

WHEREAS, the health benefits of not smoking are substantiated and well-known; and

WHEREAS, tobacco use is the leading cause of preventable death in Alaska.

NOW, THEREFORE, the Anchorage Municipal Assembly resolves

That the Assembly recognizes and supports

The American Cancer Society's GREAT AMERICAN SMOKEOUT November 18, 1999

and other efforts to eliminate the burden of addiction, disease and death caused by active tobacco use, as well as involuntary exposure to second-hand-smoke by non-smokers.
