A RESOLUTION OF THE ANCHORAGE MUNICIPAL ASSEMBLY SUPPORTING THE ESTABLISHMENT OF THE NATIONAL MUSEUM OF WOMEN'S HISTORY

WHEREAS, the historical contributions of women to our nation have been great, yet these contributions have largely gone unrecognized or have been misunderstood, leaving a gap in our nation's historical record; and

WHEREAS, to fill this gap, the National Museum of Women's History is being established in Washington, D.C.; and

WHEREAS, the National Museum of Women's History is a nonpartisan, nonprofit, educational institution dedicated to preserving and celebrating the many contributions and diverse heritage of women throughout history; and

WHEREAS, the National Museum of Women's History is expected to serve 2.5 million visitors each year, and to serve millions more with its traveling exhibits and cyber museum.

NOW, THEREFORE, the Anchorage Municipal Assembly resolves:

Section 1: That the Assembly supports the establishment of the National Museum of Women's History.

<u>Section 2:</u> That the Assembly urges Congress to make available for the National Museum of Women's History an existing building on the Mall in Washington, D.C.

<u>Section 3:</u> That the Assembly further supports the National Museum of Women's History Alaska Council, a branch of the National Museum of Women's History, being established in Alaska to preserve and celebrate the achievements of Alaska women.
