AN ORDINANCE AMENDING ANCHORAGE MUNICIPAL CODE SECTIONS
14.60.030 AND 15.70.060 TO INCREASE THE RANGE OF FINES POSSIBLE FOR
NOISE DISTURBANCES AND TO ALLOW THE ANCHORAGE POLICE
DEPARTMENT TO GIVE CITATIONS FOR VIOLATIONS OF THE ANCHORAGE
NOISE CONTROL ORDINANCE.

THE ANCHORAGE ASSEMBLY ORDAINS

Section 1: That Anchorage Municipal Code section 14.60.030 is hereby amended to
read as follows:

14.60.030 **Fine schedule.**

Section 2: That Anchorage Municipal Code section 15.70.060 is hereby amended to
read as follows:

15.70.060 **Prohibited acts and conditions.**

- A. No person shall unreasonably make, continue, or cause to be made or
continued any noise disturbance except noncommercial public speaking or

2 public assembly activities conducted on any public space or public right-of-
3 way. Notwithstanding any other provision of law, the Anchorage Police
4 Department may enforce section 15.70.060.
