AN ORDINANCE OF THE ANCHORAGE MUNICIPAL ASSEMBLY CONTINUING OR REESTABLISHING THE MUNICIPAL HEALTH & HUMAN SERVICES COMMISSION PURSUANT TO ANCHORAGE MUNICIPAL CODE SECTION 4.05.150.

THE ANCHORAGE ASSEMBLY ORDAINS

Section 1. Pursuant to Anchorage Municipal Code Section 4.05.150, the Municipal Health & Human Services Commission shall be and is hereby continued and reestablished as set forth in Anchorage Municipal Code Section 4.05.150 for an additional period of three (3) years from and after May 14, 2000. During the period of time from and after May 14, 2000 until the effective date of this ordinance, all actions of the Municipal Health & Human Services Commission, all appointments thereto and all unexpired terms of its members shall continue to be and constitute the actions of, appointments to and the unexpired terms of its members, as the case may be, as if it had not been terminated by operation of law.

<u>Section 2.</u> Nothing in this ordinance shall be taken as or constitute any approval, ratification, implementation of, or ruling or action by the Anchorage Municipal Assembly on any action of the Municipal Health & Human Services Commission.

Section 3. This ordinance shall take effect immediately upon passage and approval by the Assembly
