THE ANCHORAGE ASSEMBLY ORDAINS:

<u>Section 1:</u> That the FY 2000-2001 proposed Anchorage School District budget in the amount of \$410,505,754 has been approved and appropriated by the Anchorage Assembly and that, of said amount, the amount of \$116,540,396 shall be the amount of money to be appropriated from local property taxes or other local sources for school purposes to fund the School District for its 2000-2001 fiscal year.

Section 2: That it is the intent of the Assembly to consider the addition of up to \$8,000,000 to the FY 2000-2001 Anchorage School District budget and to the amount of money appropriated from local property taxes or other local sources for school purposes to fund the School District for its FY 2000-2001 fiscal year in the event 99PTAR, "An Act Providing Property Tax and Assessment Relief," is not approved by the voters or otherwise not put into effect.

Section 3: That this ordinance is effective upon passage and approval.
