AN ORDINANCE SUBMITTING TO THE QUALIFIED VOTERS RESIDING IN THE UPPER O'MALLEY LIMITED ROAD SERVICE AREA OF THE MUNICIPALITY AT THE REGULAR MUNICIPAL ELECTION APRIL 4, 2000, A BALLOT PROPOSITION TO CHANGE THE BOUNDARIES OF SAID SERVICE AREA BY INCLUDING IN THE UPPER O'MALLEY LIMITED ROAD SERVICE AREA ALL OF THE ROCKRIDGE ROAD RIGHT-OF-WAY BETWEEN O'MALLEY ROAD AND EAST 112TH AVENUE.

WHEREAS, the O'Malley Elementary School is located on Rockridge Road in the Hillside Area of the Municipality of Anchorage; and

WHEREAS, Rockridge Road, public road right-of-way, is the primary access to O'Malley Elementary school; and

WHEREAS, Subsections 58(a) and (b) of the 1999 House Committee Substitute for Committee Substitute for Senate Bill 32 (Finance) as amended in the House [HCS CSSB 32(FIN) am H reengrossed] appropriated \$250,000 to upgrade Rockridge Road on the condition that the Municipality agree to undertake the maintenance of Rockridge Road; and

WHEREAS, Rockridge Road is not located within any road maintenance service area from which funds may be obtained to pay for the maintenance of Rockridge Road; and

WHEREAS, in order to establish a funding source for the maintenance of Rockridge Road; now therefore
