1 AN ORDINANCE SUBMITTING TO THE QUALIFIED VOTERS RESIDING IN THE UPPER
2 O'MALLEY LIMITED ROAD SERVICE AREA OF THE MUNICIPALITY AT THE REGULAR
3 MUNICIPAL ELECTION APRIL 4, 2000, A BALLOT PROPOSITION TO CHANGE THE
4 BOUNDARIES OF SAID SERVICE AREA BY INCLUDING IN THE UPPER O'MALLEY
5 LIMITED ROAD SERVICE AREA ALL OF THE ROCKRIDGE ROAD RIGHT-OF-WAY
6 BETWEEN O'MALLEY ROAD AND EAST 112TH AVENUE.

9 WHEREAS, the O'Malley Elementary School is located on Rockridge Road in the Hillside
10 Area of the Municipality of Anchorage; and

11
12 WHEREAS, Rockridge Road, public road right-of-way, is the primary access to O'Malley
13 Elementary school; and

15 WHEREAS, Subsections 58(a) and (b) of the 1999 House Committee Substitute for
16 Committee Substitute for Senate Bill 32 (Finance) as amended in the House [HCS CSSB 32(FIN)
17 am H reengrossed] appropriated \$250,000 to upgrade Rockridge Road on the condition that the
18 Municipality agree to undertake the maintenance of Rockridge Road; and

20 WHEREAS, Rockridge Road is not located within any road maintenance service area from
21 which funds may be obtained to pay for the maintenance of Rockridge Road; and

23 WHEREAS, in order to establish a funding source for the maintenance of Rockridge Road;
24 now therefore

26 THE ANCHORAGE ASSEMBLY ORDAINS

27
28 **Section 1.** Pursuant to Anchorage Municipal Charter §9.01(a), a ballot proposition in substantially
29 the following form shall be submitted at the regular Municipal election April 4, 2000 to the qualified
30 voters residing in the Upper O'Malley Limited Road Service area:



10 **Section 2.** Anchorage Municipal Code section 27.30.700 is hereby amended by amending the
11 map of the Upper O'Malley Limited Road Service Area to include all of the Rockridge Road right-
12 of-way between O'Malley Road and East 112th Avenue.

14 **Section 3.** Section 2. of this ordinance shall become effective upon certification of the regular
15 Municipal election of April 4, 2000, if but only if, the proposition contained in Section 1. of this
16 ordinance is passed by a majority of the voters voting on said proposition. All other sections of this
17 ordinance shall become effective immediately upon its passage and approval by the Assembly.
