1 AN ORDINANCE SUBMITTING TO THE QUALIFIED VOTERS RESIDING IN THE
2 LAKEHILL LIMITED ROAD SERVICE AREA OF THE MUNICIPALITY AT THE REGULAR
3 MUNICIPAL ELECTION APRIL 4, 2000, A BALLOT PROPOSITION TO APPROVE
4 CHANGING THE BOUNDARIES OF THE LAKEHILL LIMITED ROAD SERVICE AREA TO
5 INCLUDE THE AREA BETWEEN O'MALLEY ROAD AND THE SOUTHERN BOUNDARY
6 OF THE LAKEHILL LIMITED ROAD SERVICE AREA IMMEDIATELY TO THE WEST OF
7 LAKEHILL LIMITED ROAD SERVICE AREA INCLUDING ALL OF THE ROCKRIDGE
8 ROAD RIGHT-OF-WAY.

11 WHEREAS, the O'Malley Elementary School is located on Rockridge Road in the Hillside
12 Area of the Municipality of Anchorage; and

14 WHEREAS, Rockridge Road, a public road right-of-way, is the primary access to O'Malley
15 Elementary school; and

17 WHEREAS, Subsections 58(a) and (b) of the 1999 House Committee Substitute for
18 Committee Substitute for Senate Bill 32 (Finance) as amended in the House [HCS CSSB 32(FIN)
19 am H reengrossed] appropriated \$250,000 to upgrade Rockridge Road on the condition that the
20 Municipality agree to undertake the maintenance of Rockridge Road; and

22 WHEREAS, Rockridge Road is not located within any road maintenance service area from
23 which funds may be obtained to pay for the maintenance of Rockridge Road; and

25 WHEREAS, in order to establish a funding source for the maintenance of Rockridge Road

28 THE ANCHORAGE ASSEMBLY ORDAINS

30 **Section 1.** Pursuant to Anchorage Municipal Charter §9.01(a), a ballot proposition in substantially
31 the following form shall be submitted at the regular Municipal election April 4, 2000 to the qualified
32 voters of the Municipality residing in the Lakehill Limited Road Service Area:

Shall the western boundary of the Lakehill Limited Road Service Area be extended west to include all of the area west of said service area to and including all of the Rockridge Road right-of-way between O'Malley Road and the southern boundary of the Lakehill Limited Road Area?

Rockridge Road is the access to the O'Malley Elementary School off of O'Malley Road and the southern boundary of the Lakehill Limited Road Service Area is Klatt Road as if extended to connect Birch Road and Hillside Drive.

Section 2. Anchorage Municipal Code section 27.30.700 is hereby amended by amending the map of the Lakehill Limited Road Service Area to include all of the area west of said service area to and including all of the Rockridge Road right-of-way between O'Malley Road and the southern boundary of the Lakehill Limited Road Area (Klatt Road as if extended to connect Birch Road and Hillside Drive).

Section 3. Section 2. of this ordinance shall become effective upon certification of the regular Municipal election of April 4, 2000, if but only if, the proposition contained in Section 1. of this ordinance is passed by a majority of the voters voting on said proposition. All other sections of this ordinance shall become effective immediately upon its passage and approval by the Assembly.
