Rockridge Road is the access to the O'Malley Elementary School off of O'Malley Road. The western boundary of the Lakehill Limited Road Service Area is shown on the map attached to Anchorage Ordinance No. _____ and the southern boundary of the Lakehill Limited Road Service Area is Klatt Road as if extended to connect Birch Road and Hillside Drive.

<u>Section 2.</u> Anchorage Municipal Code chapters 27.20 and 27.30 are hereby amended by adding thereto new sections 27.20.350 and 27.30.620 respectively to read as follows:

27.20.350 Rockridge Road Limited Road Service Area Board of Supervisors.

Pursuant to section 27.10.050 there is hereby established a board of supervisors for the Rockridge Road Limited Road Service Area whose members shall be appointed initially and elected in 2001, which shall function in accordance with this chapter and other applicable laws.

27.30.600 Rockridge Road Limited Road Service Area

There is hereby created a limited road service area known as the Rockridge Road Limited Road Service Area ("RRLRSA") consisting of all of the area west of the Lakehill Limited Road Service Area to and including all of the Rockridge Road right-of-way bounded on the north by O'Malley Road and on the south by Klatt Road as if extended to connect Birch Road and Hillside Drive (the southern boundary of the Lakehill Limited Road Service Area).

<u>Section 3.</u> Anchorage Municipal Code section 27.30.700 is hereby amended by adding thereto a map of the Rockridge Road Limited Road Service Area which shall be constituted by all of the area west of the Lakehill Limited Road Service Area to and including all of the Rockridge Road right-ofway bounded on the north by O'Malley Road and on the south by Klatt Road as if extended to run between Birch Road and Hillside Drive (the southern boundary of the Lakehill Limited Road Service Area).

<u>Section 4.</u> Sections 2. and 3. of this ordinance shall become effective upon certification of the regular Municipal election of April 4, 2000, if but only if, the proposition contained in Section 1. of this ordinance is passed by a majority of the voters voting on said proposition. All other sections of this ordinance shall become effective immediately upon its passage and approval by the Assembly.
