AN ORDINANCE OF THE ANCHORAGE MUNICIPAL ASSEMBLY AMENDING  
ANCHORAGE MUNICIPAL CODE SECTION 2.30.040, APPEARANCE REQUESTS, TO  
CHANGE THE DEADLINE REQUIREMENT FOR PLACEMENT BEFORE ASSEMBLY  
AFTER ACCEPTANCE FROM 14 DAYS TO SEVEN DAYS

THE ANCHORAGE ASSEMBLY ORDAINS:

Section 1: That AMC Section 2.30.040, Appearance Requests, is amended to read  
as follows:

**2.30.040**      **Appearance requests.**

- A. A person wishing to speak before the Assembly under "appearance request" must file an appearance request with the Municipal Clerk specifying the topic on which he/she intends to speak.
- B.-C. No change
- D. Appearance requests accepted by the Municipal Clerk must be placed before the Assembly no later than [14] 7 (seven) days after acceptance[.], or at the next regularly scheduled meeting if beyond the seven day period.
- E. In lieu of appearance requests, the Assembly will accept brief written communications on any subject. These communications will be reproduced and distributed by the Municipal Clerk no later than [14] 7 (seven) days after receipt[.], or at the next regularly scheduled meeting if beyond the seven day period.

Section 2: That this ordinance is effective immediately upon passage and approval.
