Veto of Assembly Motions and Actions Reducing the Applied Fund

Balance and Increasing the Areawide General Mill Levy

I am vetoing the motions and actions, passed by a majority of the Assembly, that had the effect of taxing the citizens an additional \$2 million in order to increase the Municipality's reserves an additional \$2 million.

The Municipality's current available reserves include an \$18 million reserve account from the ATU sale, \$20 million received last week from the Police and Fire Retirement settlement and more than \$22 million in fund balance. This is over \$60 million in reserves accessible by Assembly vote. In addition, the Municipality has a trust fund of over \$132 million accessible by a vote of the citizens.

I believe it is inappropriate to raise taxes another \$2 million for the purpose of increasing accessible reserves from \$60 million to \$62 million.
