AN ORDINANCE OF THE ANCHORAGE MUNICIPAL ASSEMBLY AMENDING
ANCHORAGE MUNICIPAL CODE SUBSECTION 16.60.050 M., REGARDING THE
CRITERIA FOR WAIVING PERMIT FEES FOR CHARITABLE OPERATIONS AND
ORGANIZATIONS OPERATING A FOOD ESTABLISHMENT

THE ANCHORAGE ASSEMBLY ORDAINS:

Section 1: That AMC 16.60.050 M. is amended to read as follows:

M. **[THE FOLLOWING] C[c]**haritable operations and organizations are required to have a permit under this chapter but the department may waive fees for inspection and service for establishments meeting all of the following criteria:

1. Establishments that prepare and provide food to the public at no charge, or nonprofit organizations that return proceeds collected to the organization for the purpose of maintaining the welfare of the organization;
2. Establishments, except nonprofit organizations, that are not funded by grants from local, state, or federal governments; and
3. Establishments that are operated by nonprofit corporations under the laws of Alaska whose purpose is to foster the general community welfare of the municipality.

Section 2: That this ordinance shall become effective immediately upon passage and approval.
