Amend Section 2315.1, by inserting a new paragraph after paragraph 5 as follows:

Shear walls may be designed using the latest available version of the National Earthquake Hazards Reduction Program (NEHRP) Perforated Shear Wall Methodology. Allowable Stress Design lateral forces must be multiplied by a factor of 1.4 for use with the NEHRP code.

Section 2. That Anchorage Municipal Code Section 23.85.301.1 is hereby amended to read as follows:

When of unusual shape, buildings of light-frame construction shall have their [A] lateral-force-resisting system designed in accordance with [TO RESIST THE FORCES SPECIFIED IN] the 1994 or 1997 UBC. [CHAPTER 16.] One or more of the items of 1994 UBC sections 2326.5.4.1 through 2326.5.4.7 shall be considered to constitute an unusual shape.

Section 3. That this ordinance shall become effective immediately upon its passage and approval by the Assembly.
