AN ORDINANCE OF THE ANCHORAGE MUNICIPAL ASSEMBLY REQUIRING A MORATORIUM ON ZONING, SITE PLAN, AND PLATTING APPROVALS INVOLVING CLUSTER HOUSING UNTIL THE MUNICIPALITY'S CURRENT CLUSTER HOUSING ORDINANCE IS REWRITTEN AND APPROVED.

WHEREAS, adjacent neighborhoods have raised concerns about the appearance, functionality and other impacts of developing cluster subdivisions under the current provisions of Anchorage Municipal Code Title 21; and

WHEREAS, in the face of potential cuts in municipal services, the increased costs of road maintenance and snow removal or snow storage associated with cluster developments may not be acceptable or affordable to the general community; and

WHEREAS, drainage patterns and other physical standards for cluster developments are not adequately addressed by the current code pertaining to cluster development; and

WHEREAS, cluster development provides more open space than other forms of development, but the open space is typically marginal or unusable for recreation by the residents of the cluster development, leaving reduced yards or other areas for residents to safely play or relax; and

WHEREAS, there are no design standards for cluster housing, resulting in "soldiering" of houses with virtually identical layouts and appearance, with little or no landscaping or other features to improve the visual appearance of the subdivision; and

WHEREAS, the Municipality's current cluster housing ordinance is inadequate to ensure that such housing development results in livable neighborhoods; and

WHEREAS, cluster development in steeply sloped areas may be more hazardous to pedestrians and children at play than other types of development; and

WHEREAS, the current cluster housing ordinance needs to be rewritten to address such areas as the intent of cluster housing, design standards, minimum lot sizes, open space needs, snow storage areas, vehicle parking, to include recreational vehicles, etc; and
