1 A RESOLUTION OF THE MUNICIPALITY OF ANCHORAGE APPROPRIATING FOUR  
2 MILLION, TWO HUNDRED FORTY-THREE THOUSAND, NINE HUNDRED AND  
3 TWENTY-SIX DOLLARS (\$4,243,926) FROM VARIOUS SOURCES TO THE EQUIPMENT  
4 MAINTENANCE INTERNAL SERVICE CAPITAL FUND (606) FOR THE PURPOSE OF  
5 PURCHASING VEHICLES AND EQUIPMENT

7 THE ANCHORAGE ASSEMBLY RESOLVES:

8  
9 Section 1. That a sum of three million seven hundred twenty-seven, five hundred and  
10 twenty-six dollars (\$3,727,526) is appropriated from the Equipment Maintenance Internal Service  
11 Operating Fund (601) retained earnings and is transferred to the Equipment Maintenance Internal  
12 Service Capital Fund (606) to purchase vehicles and equipment.

13  
14 Section 2. That a sum of twenty-five thousand dollars (\$25,000) is appropriated as a  
15 contribution from the Areawide General Fund (101) to the Equipment Maintenance Internal Service  
16 Capital Fund (606) to purchase vehicles and equipment for Management Information Systems  
17 Department.

18  
19 Section 3. That a sum of fourteen thousand dollars (\$14,000) is appropriated as a  
20 contribution from the Areawide General Fund (101) to the Equipment Maintenance Internal Service  
21 Capital Fund (606) to purchase vehicles and equipment for Finance Department – Property  
22 Appraisal Division.

23  
24 Section 4. That a sum of thirty-five thousand dollars (\$35,000) is appropriated as a  
25 contribution from the Anchorage Fire Service Area Fund (131) to the Equipment Maintenance  
26 Internal Service Capital Fund (606) to purchase vehicles and equipment.

27  
28 Section 5. That a sum of twenty-five thousand (\$25,000) is appropriated as a contribution  
29 from the Areawide General Fund (101) to the Equipment Maintenance Internal Service Capital  
30 Fund (606) to purchase vehicles and equipment for Property and Facility Management Department  
31 – Facility Maintenance Division.

32  
33 Section 6. That a sum of twenty-two thousand, four hundred dollars (\$22,400) is  
34 appropriated as a contribution from Areawide General Fund (101) to the Equipment Maintenance  
35 Internal Service Capital Fund (606) to purchase vehicles and equipment for Property and Facility  
36 Management - Contract Management Division.

3       Section 7. That a sum of three hundred ninety-five thousand dollars (\$395,000) is  
4 appropriated from the Anchorage Metropolitan Police SA CIP Fund (451) to the Equipment  
5 Maintenance Internal Service Capital Fund (606) to purchase vehicles and equipment for  
6 Anchorage Police Department.

7  
8       Section 8. This resolution is effective immediately upon passage and approval.
