**A RESOLUTION OF THE ANCHORAGE MUNICIPAL ASSEMBLY RECOGNIZING AND
COMMENDING THE TEAM EFFORT OF THE MANAGEMENT INFORMATION
SYSTEMS DEPARTMENT STAFF AND OTHER CITYWIDE EMPLOYEES FOR THEIR
WORK AND COMMITMENT TO THE Y2K READINESS PROGRAM**

WHEREAS, in 1996, the Municipality of Anchorage, through the leadership of the
Management Information Systems Department, began work to replace or repair existing
production systems to meet Y2K compliancy; and

WHEREAS, this effort led to all of the Departments within the Municipality, in
addition to other major systems including property tax, zoning, hotel/motel tax, tobacco tax,
and others, becoming modified prior to Y2K; and

WHEREAS, staff from the Management Information Systems Department and user
departments worked long hours, over a long period of time, as team players to implement
and test new software; and, at the same time, they continued to keep the City operating
efficiently; and

WHEREAS, in addition to long hours, employees sacrificed their personal lives to
ensure that the City would face no problems as we entered into the New Millennium; and

WHEREAS, as a result of the combined efforts of Municipal Departments and key
personnel, the Municipality of Anchorage has a "clean bill of health" in its Y2K
compliance efforts.

NOW, THEREFORE, the Anchorage Assembly resolves

That this body recognizes and commends the Management Information Systems
Department staff and other citywide employees whose team efforts resulted in Y2K being
a nonevent for the citizens of Anchorage.
