A RESOLUTION OF THE ANCHORAGE MUNICIPAL ASSEMBLY HONORING AND **REMEMBERING RONALD L. LARSON**

WHEREAS, Ron Larson moved to Alaska in 1959 and worked as a social studies and history teacher at Palmer High School; and

WHEREAS, at Palmer High, Ron also coached the boys basketball team to two State Championships (1969 and 1970), and he was the school's Athletic Director for 17 years; and

WHEREAS, Ron began his public service career as a City Councilman in Palmer and as a Matanuska-Susitna Borough Assemblymember in 1968; and

WHEREAS, in 1973, Ron became the first elected Mayor of the Matanuska-Susitna Borough - a position he held for nine years; and

WHEREAS, from 1975 to 1998, Ron also taught at Mat-Su College; and

WHEREAS, after retiring from teaching in 1982, Ron was elected to the State House of Representatives, where he served 12 years, including many years as a House Finance Committee member; and

WHEREAS, as a State Legislator, Ron was recognized for his expertise on education funding, his working relationship with all political parties, and his concern for all regions of the State; and

WHEREAS, Ron passed away on February 10, 2000 at the Sitka Pioneers Home.

NOW, THEREFORE, the Anchorage Municipal Assembly resolves:

That the Assembly honors and remembers

Ronald L. Larson

for his years of service as an educator, coach, and legislator - we will certainly miss this true "statesman."
