**A RESOLUTION OF THE ANCHORAGE MUNICIPAL ASSEMBLY ENCOURAGING THE
ANCHORAGE SCHOOL BOARD TO RECONSIDER ITS DECISION TO USE PUBLIC MONEY
TO FUND THE SCHOOL DISTRICT SUPERINTENDENT'S PRIVATE LAWSUIT**

WHEREAS, the Anchorage School Board recently approved use of public money to fund a lawsuit brought by the School District Superintendent against a private citizen; and

WHEREAS, this approval decision was made by the School Board in private session without the benefit of public comment; and

WHEREAS, this Superior Court lawsuit, which does not seek any monetary damages, was not filed by the Anchorage School District or the Anchorage School Board, on behalf of itself or the Superintendent - it is a private lawsuit filed by the Superintendent; and

WHEREAS, this body questions the School Board's decision to allow use of taxpayer money to fund a private lawsuit, especially given the community's educational needs and the limited resources available to meet these needs.

NOW, THEREFORE, the Anchorage Municipal Assembly resolves

That the Assembly encourages the Anchorage School Board to reconsider its decision to use public money to fund the School Superintendent's private lawsuit.
