WHEREAS, the Municipality has engaged in negotiations regarding the acquisition of property rights for the parcels listed in the attached Exhibit A, and;

WHEREAS, the Assembly has previously authorized eminent domain proceedings and approval of the Decisional Document, Parts I and II, and;

WHEREAS, the defendants in said previously filed eminent domain cases have objected to the takings on the basis of alleged omissions in the Decisional Document, and;

WHEREAS, further delay would have a detrimental effect upon the cost and scheduling of the project, and;

WHEREAS, the Assembly has received, as of the date of the public hearing on this resolution, a request for the approval of the exercise of the Municipality's eminent domain power,

NOW THEREFORE, the Anchorage Assembly resolves:

SECTION 1. The property interests described in Exhibit A are to be acquired for the construction of the 15th Avenue Safety Improvements, a public project, the design of which has been determined to provide the greatest public good for the least private injury. The Municipality is hereby authorized to acquire necessary property rights in regard to the following parcels for right of way for the 15th Avenue Safety Improvements between Ingra Street and Sitka Street, more specifically described in Exhibit A.
